WE CONTINUE TO BUILD ADVOCACY CAPACITY AND ENGAGEMENT ACROSS OUR NETWORK BY DEVELOPING ADVOCACY TRAINING PROGRAMS FOR FOOD BANK STAFF AND PROVIDING GRANTS TO OUR NETWORK FOR ADVOCACY.
